

**CITY OF PRINCE GEORGE**  
**BYLAW NO. 8976**

**A Bylaw to amend the “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004”.**

**WHEREAS** Council enacted “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004”, to establish the fees and charges set out for the City;

**AND WHEREAS** Council deems it desirable to amend the “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004”, Schedule “A”, Section A-2 Business License table, and adding to Schedule A-5(a) Fees and Charges for Development Procedures to establish the fees and charges for a Cannabis Retail and Cannabis Production Facility business license;

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004”, be amended as follows:
  - a) that Schedule “A”, Section A-2 Business Licence: Fees and Charges for Business License be amended by adding the following business license categories and business license fees to the last table:

Cannabis Retail	\$1,000
Cannabis Production Facility	\$1,000

- b) that Schedule “A”, Section A-5(a) Development Services Fees and Charges for Development Procedures be amended by adding the following application types and associated fees as a new category to the table:

Cannabis License Application	
Cannabis Retail: new license	\$1,200 + notification <sup>1</sup>
Cannabis Retail: change to an existing license	\$800 + notification <sup>1</sup>
Development Information Meeting if required <sup>2</sup>	Additional \$250

2. The Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this bylaw.
3. This Bylaw may be cited for all purposes as “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004, Amendment Bylaw No. 8976, 2018”.

READ A FIRST TIME THIS 17 DAY OF SEPTEMBER , 2018.

READ A SECOND TIME THIS 17 DAY OF SEPTEMBER , 2018.

Third reading passed by a MAJORITY decision of Members of City Council present and eligible to vote.
