

CITY OF PRINCE GEORGE

BYLAW NO. 6961

A Bylaw to amend the "City of Prince George Parking and Traffic Bylaw No. 6056, 1993"

WHEREAS pursuant to the Municipal and Motor Vehicle Acts, Council has enacted "City of Prince George Parking and Traffic Bylaw No. 6056, 1993" to regulate parking and traffic on highways within the City;

AND WHEREAS Council is now desirous of repealing Part III – PERMIT PARKING, Section 59., Convention Parking Permit, of said Bylaw;

AND WHEREAS Council is now desirous of substituting therefor a new Part III – PERMIT PARKING, Section 59, of said Bylaw, which new section would pertain to Parking Permits for persons honoured with Freedom of the City;

NOW, THEREFORE, the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. Part III – PERMIT PARKING, Section 59., Convention Parking Permit, of "City of Prince George Parking and Traffic Bylaw No. 6056, 1993" (as amended) is hereby repealed in its entirety.
2. A new Part III – PERMIT PARKING, Section 59., Freedom of the City Parking Permit is substituted therefor as follows:

59. Freedom of the City Parking Permit

1. Eligibility

Until the council revokes the honour conferred, a person given freedom of the City shall be provided with a parking placard which permits free parking at a parking space controlled by a parking meter up to the maximum time permitted by such meter.

2. Regulation of Use

- a) Freedom of the City parking placards will be provided to those eligible for them by the City's Bylaw Services Division.
- b) The parking placard must be visibly displayed in the front windshield of the holder's vehicle.

- c) The parking placard is for the exclusive use of the person honoured with Freedom of the City, and is not, under any circumstances, to be used by anyone other than that person.
- d) Vehicles displaying a valid Freedom of the City parking placard may park at a parking space controlled by a parking meter free of charge up to the maximum time permitted by such meter.

3. That **SCHEDULE "C" - PARKING PERMIT RATES** of "City of Prince George Parking and Traffic Bylaw No. 6056, 1993" (as amended), be, and is, hereby amended by deleting all references to "Convention Parking Permit" therein, and adding the following words and phrases contained in parenthesis thereto:

- a) Type of Permit - "Freedom of the City Parking Permit",
Valid - "Until revoked", Fee - "No fee".

4. This bylaw may be cited as "City of Prince George Parking and Traffic Bylaw No. 6056, 1993, Amendment Bylaw No. 6961, 1998".


READ A FIRST TIME THIS THE *24th* DAY OF *AUGUST*, 1998.
