

**CITY OF PRINCE GEORGE**  
**BYLAW NO. 9282, 2022**

**A Bylaw to amend the “City of Prince George Bylaw Notice Enforcement Bylaw No. 8813, 2016”.**

**WHEREAS** Council enacted “City of Prince George Bylaw Notice Enforcement Bylaw No. 8813, 2016” to establish a process for bylaw enforcement through the issuance of Bylaw Notices;

**AND WHEREAS** Council deems it desirable to amend the “City of Prince George Bylaw Notice Enforcement Bylaw No. 8813, 2016”, by inserting additional Bylaw Contraventions and Fines to “Schedule “B” – Bylaw Contraventions and Fines”;

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled,  
**ENACTS AS FOLLOWS:**

1. That “City of Prince George Bylaw Notice Enforcement Bylaw No. 8813, 2016”, be amended as follows:
  - a. that Bylaw Contraventions and Fines for “City of Prince George Election and Political Signs Bylaw No. 8867, 2017” be added to Schedule “B” – Bylaw Contravention and Fines, as shown on Appendix “A”, attached to and forming part of this Bylaw.
2. The Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.
3. This Bylaw may be cited for all purposes as “City of Prince George Bylaw Notice Enforcement Bylaw No. 8813, 2016, Amendment Bylaw No. 9282, 2022”.




