

**CITY OF PRINCE GEORGE**  
**BYLAW NO. 7542**

A Bylaw of the City of Prince George to provide for exemption from taxation of land, improvements or both of certain real property under Section 359 of the Local Government Act, RSBC 1996, Chapter 323.

**WHEREAS** Section 341 (2) (g) of the Local Government Act, provides for the exemption from taxation of certain real property;

**AND WHEREAS** Section 344 (1) of the Local Government Act provides that an exemption from taxation under Section 341 may apply to the whole or a part of the taxable assessed value of land, improvements, or both;

**AND WHEREAS** the property described in Section 1 of this bylaw is an institution licensed under the Community Care Facility Act;

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That pursuant to Section 341 (2) (g) of the Local Government Act, the following described lands, together with any improvements thereon, are exempt from taxation, to the extent indicated, under Section 359 for the year 2004:

1.1 Lot 26, District Lot 913, Cariboo District, Plan 7787, except Plan 21497, (100% of the land and improvements).

2. This Bylaw may be cited for all purposes as "City of Prince George Tax Exemption Bylaw No. 7542, 2003".


READ A FIRST TIME THIS THE 6<sup>th</sup> DAY OF October, 2003.
