

CITY OF PRINCE GEORGE
BYLAW NO. 8732

A Bylaw to amend the "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004".

WHEREAS Council enacted "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", to establish the fees and charges set out for the City;

AND WHEREAS Council deems it desirable to amend the "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", by amending the fees and charges in Schedule "A", Section "A-6" that establish the fees and charges for Garbage Collection; and by amending the fees and charges in Schedule "B", Section "B-4" that establish the fees and charges for Aquatics;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That Schedule "A", Section "A-6" of the "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", be amended as follows:

- a. By Inserting the following fee under the Miscellaneous Service Fees category:

Container Exchange Fee (to increase container size)	\$30.00

2. That Schedule "B", Section "B-4" of the "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", be amended as follows:

- a. By Inserting the following fee into Section "B-4(g) Two Dollar Admission:

Pro-D Days	Two Dollar Admission Swims are valid during all School District #57 Professional Development Days.

- b. By deleting the words "or professional development days" from Section "B-4(g) Two Dollar Admission:

Two Dollar Admission Swims are not valid during special events, statutory holidays, school vacations, or professional development days

3. The Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this bylaw.
4. This Bylaw may be cited for all purposes as "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004, Amendment Bylaw No. 8732, 2016".
