

**CITY OF PRINCE GEORGE**

**BYLAW NO. 7860**

**A Bylaw of the City of Prince George to amend City of Prince George Downtown Revitalization Tax Exemption Bylaw No. 7735, 2005.**

**WHEREAS** Council deems it desirable to ensure that "C1: Downtown" and "Prince George Zoning Bylaw No. 7850, 2007" are referenced correctly in the existing "City of Prince George Downtown Revitalization Tax Exemption Bylaw No. 7735, 2005";

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That the recital clause of the aforementioned bylaw is hereby amended by replacing the words "C-1 (Central Business District)" with "C1: Downtown" and "Prince George Zoning Bylaw No. 3482, 1980" with "Prince George Zoning Bylaw No. 7850, 2007".
2. That Section 2, the definition of "Revitalization Area", is hereby amended by replacing the words "C-1 (Central Business District)" with "C1: Downtown" and "Prince George Zoning Bylaw No. 3482, 1980" with "Prince George Zoning Bylaw No. 7850, 2007".
3. That Section 6 is hereby amended by replacing the words "C-1 (Central Business District)" with "C1: Downtown" and "Prince George Zoning Bylaw No. 3482, 1980" with "Prince George Zoning Bylaw No. 7850, 2007".
4. That Schedule "B" is hereby amended by replacing the words "C-1 (Central Business District)" with "C1: Downtown" and "Prince George Zoning Bylaw No. 3482, 1980" with "Prince George Zoning Bylaw No. 7850, 2007".
5. That Schedule "C" is hereby amended by replacing the words "C-1 (Central Business District)" with "C1: Downtown" and "Prince George Zoning Bylaw No. 3482, 1980" with "Prince George Zoning Bylaw No. 7850, 2007".
6. The Mayor and City Clerk are hereby empowered to do all things necessary to give effect to this bylaw.
7. This bylaw may be cited for all purposes as "City of Prince George Downtown Revitalization Tax Exemption Bylaw No. 7735, 2005, Amendment Bylaw No. 7860, 2007".


READ A SECOND TIME THIS THE 2nd DAY OF APRIL , 2007.
