

**CITY OF PRINCE GEORGE**

**BYLAW NO. 7564**

**A Bylaw to amend Manufactured Home Park Bylaw No. 6091, 1993, by removing the fees and charges included therein and placing them in "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004".**

**WHEREAS** Council of the City of Prince George enacted "Prince George Manufactured Home Parks Bylaw No. 6091, 1993", to regulate the construction, servicing, operation and expansion of manufactured home parks within the City of Prince George;

**AND WHEREAS** Council wishes to amend Bylaw 6091 by removing the fees and charges levied therein and placing them in "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004";

**NOW THEREFORE** Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. Schedule "A" is hereby removed in its entirety and placed in "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004" as Schedule "A-8(a)".
2. Section 8.2 is hereby removed in its entirety and replaced by the following:  
8.2 Fees  
The Building Inspector will determine and collect the fees for the manufactured home park permit pursuant to Schedule "A-8(a)" of "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004".
3. Section 8.6 is hereby amended by removing the words "and a renewal fee is paid in accordance with Schedule "A" of this bylaw." and replacing them with the words "and a renewal fee is paid in accordance with Schedule "A-8(a)" of "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004".
4. Section 8.7 is hereby amended by removing the words "in accordance with Schedule "A" of this bylaw" and replacing them with the words "in accordance with Schedule "A-8(a)" of "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004".
5. Section 11.5 is hereby amended by removing the words "Schedule "A" and replacing them with the words "Schedule "A-8(a)" of "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004".
6. The Mayor and Clerk are hereby empowered to do all things necessary to give effect to this Bylaw.

5. This Bylaw may be cited for all purposes as "Prince George Manufactured Home Park Bylaw No. 6091, 1993, Amendment Bylaw No. 7564, 2004".

READ A SECOND TIME THIS THE 4<sup>th</sup> DAY OF October, 2004.

READ A THIRD TIME THIS THE 4<sup>th</sup> DAY OF October, 2004.
