

**CITY OF PRINCE GEORGE**  
**BYLAW NO. 8462**

**A Bylaw of the City of Prince George to repeal Downtown Off-Street Parking Future Expenditure Reserve By-Law No. 5232, 1988, to establish a new Downtown Off-Street Parking Reserve Fund in its place, and to authorize the transfer of all monies held in the old Downtown Off-Street Parking Future Expenditure Reserve to the new Downtown Off-Street Parking Reserve Fund.**

**WHEREAS** the Prince George Parking Area By-law No. 1996, 1968, as amended, established the downtown off-street parking area, authorized the undertaking of the provision of off-street parking facilities for the special benefit of that area, and authorized the Council to levy and impose within the downtown off-street parking area a rate upon lands and improvements;

**AND WHEREAS** the Council imposes a rate upon lands and improvements within the downtown off-street parking area pursuant to a tax rates bylaw adopted annually by Council;

**AND WHEREAS** the Downtown Off-Street Parking Future Expenditure Reserve By-Law No. 5232, 1988, established the Downtown Off-Street Parking Future Expenditure Reserve fund, for future expenditures for the purposes of downtown off-street parking, pursuant to the *Municipal Act* provisions in force at that time;

**AND WHEREAS** the applicable provisions of the said *Municipal Act* regarding capital works reserve funds have been repealed and ultimately replaced with provisions under Division 4 [*Reserve Funds*] of Part 6 of the *Community Charter*;

**AND WHEREAS** Council wishes to repeal and replace Downtown Off-Street Parking Future Expenditure Reserve By-Law No. 5232, 1988 to reflect current legislative authority and terminology applicable to the reserve fund;

**NOW THEREFORE** the Council of the City of Prince George in open meeting assembled, **ENACTS AS FOLLOWS:**

1. There is hereby established a reserve fund, entitled the "Downtown Off-Street Parking Reserve Fund".
2. The purpose of the Downtown Off-Street Parking Reserve Fund is to hold monies received in respect of rates imposed and levied for the purposes of the downtown off-street parking area established by Prince George Parking Area By-law No. 1996, 1968, as amended.
3. Funds deposited into the Downtown Off-Street Parking Reserve Fund, and interest earned thereon, may only be used for the purposes of providing new and existing off-street parking spaces within the downtown off-street

parking area, in accordance with Prince George Parking Area By-law No. 1996, 1968, as amended , including without limitation:

- (a) for the acquisition of land or an interest in land, and costs associated therewith, for the purposes of providing such off-street parking spaces; and
  - (b) the development, construction, expansion or refurbishment of off-street parking facilities, and assets associated therewith.
4. If any portion of this Bylaw is held to be invalid by a court of competent jurisdiction, such invalidity shall not affect the validity of the remaining portions of this Bylaw.
  5. All money held in the Downtown Off-Street Parking Future Expenditure Reserve established under the Downtown Off-Street Parking Future Expenditure Reserve By-Law No. 5232, 1988, shall be transferred to the Downtown Off-Street Parking Reserve Fund established under this Bylaw.
  6. Downtown Off-Street Parking Future Expenditure Reserve By-Law No. 5232, 1988, is hereby repealed.
  7. This Bylaw may be cited for all purposes as "Downtown Off-Street Parking Reserve Fund Bylaw No. 8462, 2012".
