

CITY OF PRINCE GEORGE
BYLAW NO. 8104

A Bylaw of the City of Prince George to amend the text of the "City of Prince George Zoning Bylaw No. 7850, 2007".

WHEREAS pursuant to the provisions of Section 903 of the Local Government Act, in relation to zoning, the Council of the City of Prince George is empowered to make regulations thereto;

AND WHEREAS City of Prince George Zoning Bylaw No. 7850 has been passed to make regulations thereto;

AND WHEREAS the Council of the City of Prince George has deemed it desirable that the text be amended of the aforementioned bylaw to permit "horse racing teletheatre" under the definition for "Gaming Facility";

APPLICANT: L & M Engineering for Otter Properties Ltd.
LOCATION: 2003 Highway 97 South (Text Amendment)

AND WHEREAS a Public Hearing was held in accordance with the Local Government Act and notice of such hearing was given as required by Bylaw;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That the "City of Prince George Zoning Bylaw No. 7850, 2007", Section 2.3.6., be, and is, hereby amended by replacing the "Gaming Facility" definition with the following new definition:

Gaming Facility: casino gaming with not more than 575 electronic gaming machines (slot machines or community gaming units), 15 gaming tables, permanent bingo with not more than 650 gaming seats, licensed under the *Gaming Control Act*, horse racing teletheatre, and may include the accessory retail sale of British Columbia Lottery Corporation products, spectator entertainment and patron participation entertainment.

2. That the Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.
3. That this Bylaw may be cited for all purposes as the "City of Prince George Zoning Bylaw No. 7850, 2007, Amendment Bylaw No. 8104, 2009".
