

**CITY OF PRINCE GEORGE**  
**BYLAW NO. 8746**

**A Bylaw of the City of Prince George to authorize the borrowing of funds under off-street parking funds for the estimated cost of the Plaza Parkade Upgrade Project.**

**WHEREAS** the estimated cost of the Plaza Parkade Upgrade Project, including expenses incidental thereto, is the sum of one million one hundred and seventy thousand dollars (\$1,170,000), which is the amount of debt intended to be borrowed under this Bylaw;

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. The Council is hereby empowered and authorized to undertake and carry out or cause to be carried out the Plaza Parkade Upgrade Project, generally in accordance with the plans on file in the municipal office, and to do all things necessary in connection therewith and without limiting the generality of the foregoing:
  - a. To borrow upon the credit of the municipality a sum not exceeding one million one hundred and seventy thousand dollars (\$1,170,000); and
  - b. To acquire all such real property, easements, rights-of-way, licenses, rights or authorities as may be requisite or desirable for or in connection with the Plaza Parkade Upgrade Project.
2. The maximum term for which debentures may be issued to secure the debt created by this Bylaw is twenty (20) years.
3. This Bylaw may be cited for all purposes as "Plaza Parkade Upgrade Loan Authorization Bylaw No. 8746, 2016".
