

CITY OF PRINCE GEORGE

BYLAW NO. 8120

A Bylaw of the City of Prince George to rezone certain lands and to amend the Prince George Zoning Bylaw No. 7850, 2007.

WHEREAS pursuant to the provisions of Section 903 of the Local Government Act, in relation to zoning, the Council of the City of Prince George is empowered to make regulations thereto;

AND WHEREAS Bylaw No. 7850 has been passed to make regulations thereto;

AND WHEREAS the Council of the City of Prince George has deemed it desirable that certain lands be rezoned from AF: Agriculture and Forestry and AR3m: Rural Residential to AF: Agriculture and Forestry and AR2: Rural Residential for rural residential development;

APPLICANT: Judith E. Edgson
LOCATION: 7307 Giscome Road

AND WHEREAS a Public Hearing was held in accordance with the Local Government Act and notice of such hearing was given as required by Bylaw;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That Council amend the "City of Prince George Zoning Bylaw No. 7850, 2007", as follows: the North East ¼ of District Lot 634, Cariboo District, Except Firstly: Parcel A (D2212), Secondly: Part on Plan 8488, Thirdly: Part on Plan 8956, Fourthly: Part on Plan 12915, Fifthly: Part on Plan 13121, Sixthly: Part on Plan 16233, Seventhly: Part on Plan 26295, Eighthly: Part on Plan PGP35818, and Ninthly: Part on Plan BCP26911 from AF: Agriculture and Forestry and AR3m: Rural Residential to AF: Agriculture and Forestry and AR2: Rural Residential, as shown on Appendix "A" to Bylaw No. 8120. .
2. That the Zoning Map referred to as Schedule "A" of the "City of Prince George Zoning Bylaw No. 7850, 2007", shall be amended accordingly.
3. That the Mayor and Clerk are hereby empowered to do all things necessary to give effect to this Bylaw.
4. That this Bylaw may be cited for all purposes as the "City of Prince George Zoning Bylaw No. 7850, 2007, Amendment Bylaw No. 8120, 2008".

Third Reading passed by a **unanimous** decision of Members of City Council present and eligible to vote.

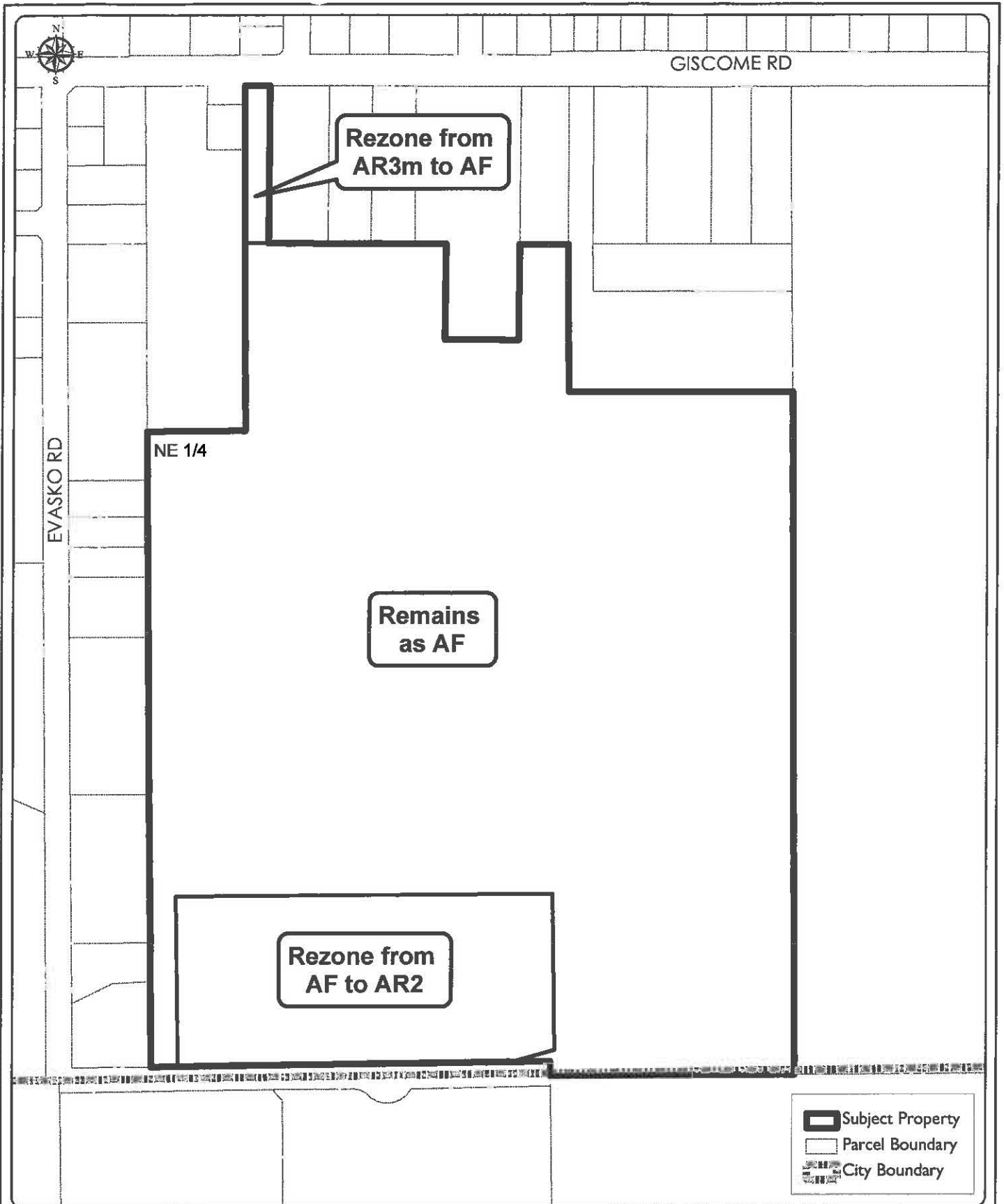
ADOPTED THIS THE **29th** DAY OF **SEPTEMBER**, **2008**, BY A
