BYLAW NO. 8470

A Bylaw of the City of Prince George to rezone certain lands and to amend the City of Prince George Zoning Bylaw No. 7850, 2007.

WHEREAS pursuant to the provisions of Section 903 of the Local Government Act, in relation to zoning, the Council of the City of Prince George is empowered to make regulations thereto;

AND WHEREAS "City of Prince George Zoning Bylaw No. 7850, 2007" has been adopted to make regulations thereto;

AND WHEREAS the Council of the City of Prince George has deemed it desirable that certain lands be rezoned from P1: Parks and Recreation to Z8: Regional Shopping to facilitate the subdivision and subsequent commercial development on the subject properties, or other uses, pursuant to the Z8: Regional Shopping zoning designation;

That the "City of Prince George Zoning Bylaw No. 7850, 2007", be, and is, hereby amended as follows: the portion of Parcel 1, Except Part on Plan BCP25199, District Lot 8173, 8176, 8179 and 8180, Cariboo District, Plan BCP10189 is hereby rezoned from P1: Parks and Recreation to Z8: Regional Shopping, as shown outlined in heavy black line on the map attached to, and forming part of, this bylaw as Appendix "A".
- That the Zoning Map referred to as Schedule "A" of the "City of Prince George Zoning Bylaw No. 7850, 2007", shall be amended accordingly.
- That the Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.


