A Bylaw to amend the “City of Prince George Permissive Tax Exemption Bylaw No. 8696, 2015”.

**WHEREAS** “City of Prince George Tax Exemption Bylaw No. 8696, 2015” provides the exemption from taxation of land, improvements, or both of certain real property;

**AND WHEREAS** Council deems it desirable to amend “City of Prince George Permissive Tax Exemption Bylaw No. 8696, 2015”;

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That pursuant to Sections 224 (1), 224 (2) (a), (f), (g) and (h) of the *Community Charter*, the following described lands, together with any improvements, thereon, are exempt from taxation under Section 197 of the *Community Charter*, for the 2017-2018 taxation years.
2. That “City of Prince George Permissive Tax Exemption Bylaw No. 8696, 2015” be amended as follows:
  - a. That section 1.19 a and 1.19 b be deleted and replaced with:


READ A SECOND TIME THIS 17<sup>th</sup> DAY OF OCTOBER , 2016.

All three readings passed by a **UNANIMOUS** decision of members of City Council present and eligible to vote.


