

CITY OF PRINCE GEORGE
BYLAW NO. 8815

A Bylaw of the City of Prince George to amend Animal Control Bylaw No. 7771, 2005.

WHEREAS Council enacted “Animal Control Bylaw No. 7771, 2005” to regulate, prohibit and impose requirements in relation to animals, including bylaw enforcement;

AND WHEREAS Council deems it desirable to amend the “Animal Control Bylaw No. 7771, 2005” by removing the fines schedule set out in the Bylaw and to authorize bylaw contraventions that may be dealt with by Bylaw Notice;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That the “Animal Control Bylaw No. 7771, 2005”, be amended as follows:

1.1 Delete Section 10.1 in its entirety and replace with a new Section 10.1 as follows:

“10.1 This Bylaw may be enforced,

- a) by an Information laid in accordance with the *Offence Act*;
- b) by means of a ticket under the *Community Charter*;
- c) by Bylaw Notice in accordance with the “*Local Government Bylaw Notice Enforcement Act*”; or
- d) by a combination of the above noted methods in (a), (b) and (c).”

1.2. Delete Section 10.2 in its entirety and replace with a new Section 10.2 as follows:

“10.2 With respect to enforcement further to a ticket issued pursuant to the *Community Charter*, the fines outlined in the “City of Prince George Ticket Information Utilization Bylaw No. 5422, 1990”, as amended or replaced from time to time., shall apply.”

1.3. Delete Section 10.3 (d) in its entirety and replace with a new Section 10.3 (d) as follows:

“10.3

- (d) The minimum fine for any other offence is the fine outlined in Column A1 of Schedule “B” of the “City of Prince George Bylaw Notice of Enforcement Bylaw No. 8813, 2016”, as amended or replaced from time to time.”

1.4. Delete Section 10.3 (e) in its entirety.

1.5. Delete Section 10.4 in its entirety.

- 1.6. Amend Section 10.5 by adding the words "or the City of Prince George Bylaw Notice Enforcement Bylaw No. 8813, 2016", as amended or replaced from time to time." immediately following the words "City of Prince George Ticket Information Utilization Bylaw No. 5422, 1990".
- 1.7. Delete Schedule "A" Animal Control Bylaw Fine Schedule in its entirety.
- 2. That the Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.
- 3. That this Bylaw may be cited for all purposes as the "Animal Control Bylaw No. 7771, 2005, Amendment Bylaw No. 8815, 2017".

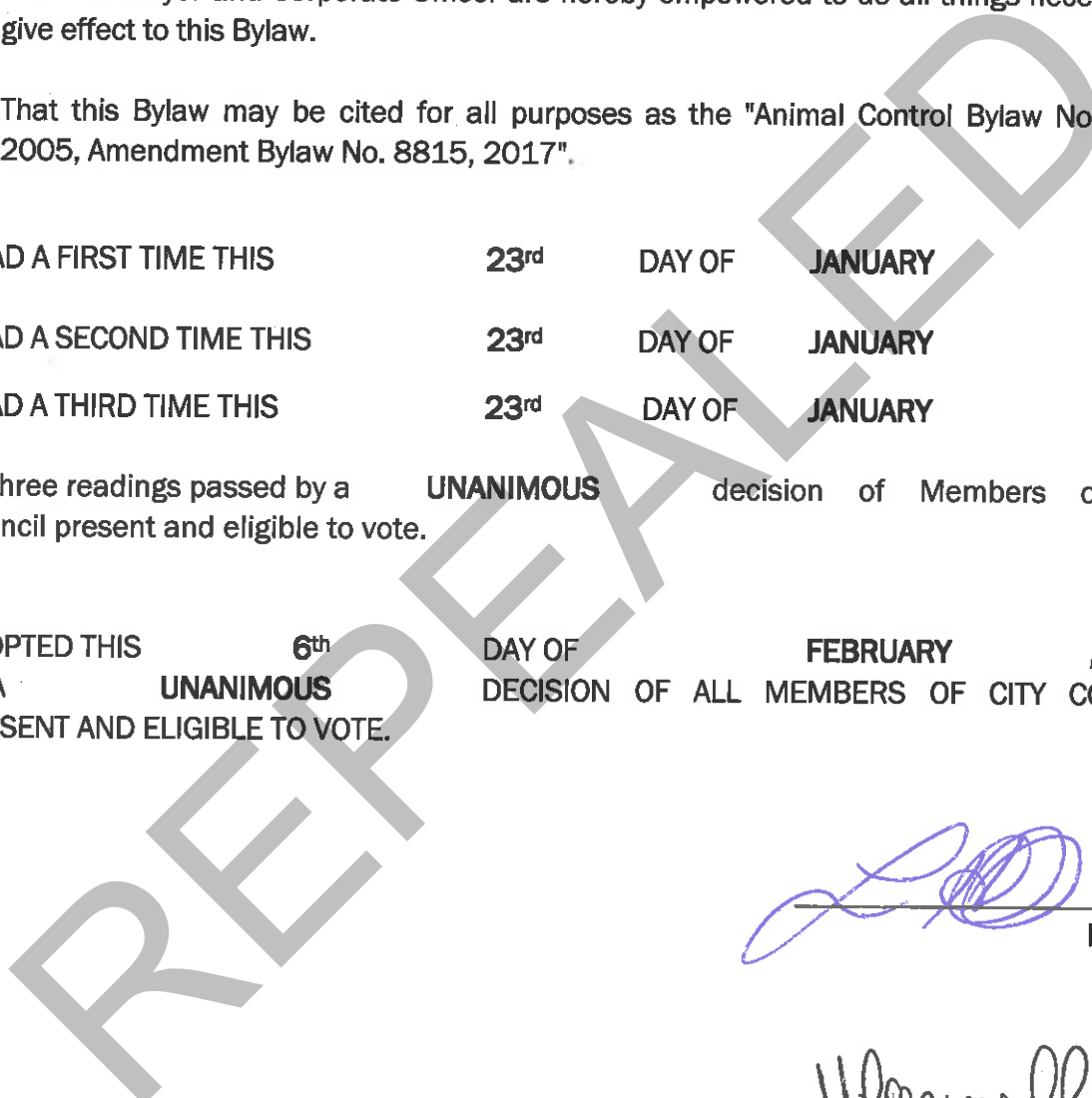

READ A THIRD TIME THIS **23rd** DAY OF **JANUARY** , 2017.


All three readings passed by a **UNANIMOUS** decision of Members of City Council present and eligible to vote.
