

CITY OF PRINCE GEORGE
BYLAW NO. 8892

A Bylaw to amend “Election and Other Voting Procedures Bylaw No. 6067, 1993”

WHEREAS pursuant to the *Local Government Act* Council may, by bylaw, determine various procedures and requirements to be applied to the conduct of local government elections and other voting;

AND WHEREAS Council deems it desirable to amend those voting procedures and requirements established by bylaw under that authority;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. This Bylaw may be cited for all purposes as “Election and Other Voting Procedures Bylaw No. 6067, 1993, Amendment Bylaw No. 8892, 2017”.
2. That the “Election and Other Voting Procedures Bylaw No. 6067, 1993” be amended as follows:
 - a) that subsection 11.3.13 be deleted in its entirety and replaced with a new section 11.3.13 as follows:

“11.3.13 Sample **ballots** generally in the form attached as Schedule “A” or Schedule “B” to this Bylaw may be used in an **automated vote counting system.**”;
 - b) that Schedule “A” be deleted in its entirety and replaced with a new Schedule “A”, as attached to and forming part of this Bylaw; and
 - c) that a new Schedule “B” be inserted, as attached to and forming part of this Bylaw.

READ A SECOND TIME THIS 21st DAY OF AUGUST , 2017.


READ A THIRD TIME THIS 21st DAY OF AUGUST , 2017.

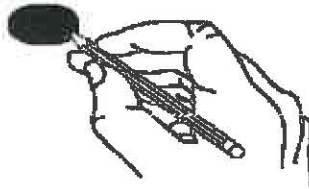

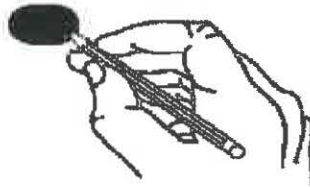
