

CITY OF PRINCE GEORGE
BYLAW NO. 8673

A Bylaw to amend the "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004".

WHEREAS Council enacted "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", to establish the fees and charges set out for the City;

AND WHEREAS Council deems it desirable to amend the "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", by amending the fees and charges in Schedule "B", Section "B-7" that establish the fees and charges for Prince George Playhouse Theatre;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That Schedule "B", Section "B-7" of the "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", be amended by deleting Section "B-7" and replacing it with a new Section "B-7", as attached to and forming part of this Bylaw as Appendix "A".
2. This Bylaw shall come into force and be effective on July 1, 2016.
3. The Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this bylaw.
4. This Bylaw may be cited for all purposes as "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004, Amendment Bylaw No. 8673, 2016".


