A Bylaw to amend the "City of Prince George Permissive Tax Exemption Bylaw No. 8695, 2015".

**WHEREAS** "City of Prince George Permissive Tax Exemption Bylaw No. 8695, 2015" provides the exemption from taxation of land, improvements, or both of certain real property;

**AND WHEREAS** Council deems it desirable to amend "City of Prince George Permissive Tax Exemption Bylaw No. 8695, 2015";

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That pursuant to Sections 224 (2)(a), (d), (i) and (j) of the *Community Charter*, the following described lands, together with any improvements, thereon, are exempt from taxation under Section 197 of the *Community Charter*, for the 2017-2018 taxation years.

2. That "City of Prince George Tax Exemption Bylaw No. 8695, 2015" be amended as follows:

a. That section 1.1 be amended by adding the following:

Applicant: St. Vincent de Paul Society

f. That Section 1.34 be amended by adding the following:

Lot 13 Block 43 District Lot 343 Plan 1268 See Explanation Plan PGP38528 (100% Land and Improvements, including Thrift Store, excluding other Commercial areas)

Roll Number: 00-00893-000  
Location: 1180 3<sup>rd</sup> Ave  
Applicant: St. Vincent de Paul Society

2. This Bylaw may be cited for all purposes as "City of Prince George Permissive Tax Exemption Bylaw No. 8695, 2015, Amendment Bylaw No. 8800, 2016".

READ A SECOND TIME THIS 17<sup>th</sup> DAY OF OCTOBER, 2016.



READ A THIRD TIME THIS 17<sup>th</sup> DAY OF OCTOBER, 2016.
