

**CITY OF PRINCE GEORGE**

**BYLAW NO. 7367**

**A Bylaw of the City of Prince George to stop up and close to traffic a lane adjacent to Parcel 1, District Lot 934, Cariboo District, Plan PGP 43644.**

**WHEREAS** the City of Prince George has been requested to stop up and close to traffic a lane adjacent to Parcel 1, District Lot 934, Cariboo District, Plan PGP 43644;

**AND WHEREAS** the Council of the City of Prince George has deemed it desirable that said lane be stopped and closed to traffic;

**AND WHEREAS** an opportunity has been provided for persons who consider they are affected by the Bylaw to make representations to Council;

**AND WHEREAS** the City of Prince George intends to Petition the Minister of Community, Aboriginal, and Women's Services to vest title of the aforesaid closed lane in the name of the City, for subsequent sale and transfer to the adjacent property owner (land known as Parcel 1, District Lot 934, Cariboo District, Plan PGP 43644);

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That lane adjacent to Parcel 1, District Lot 934, Cariboo District, Plan PGP 43644, as shown outlined in heavy black line on the map attached to, and forming part of, this Bylaw as Appendix "A", is hereby stopped up and closed to traffic.
2. The Mayor and Clerk of the City of Prince George are hereby authorized to Petition the Minister of Community, Aboriginal, and Women's Services to vest title of the aforesaid closed road in the name of the City for subsequent sale and transfer to the adjacent property owner (land known as Parcel 1, District Lot 934, Cariboo District, Plan PGP 43644);
3. Prior to adoption, this Bylaw shall be advertised once a week for two consecutive weeks in a newspaper circulating in the municipality.
4. The Mayor and Clerk are hereby empowered to do all things necessary to give effect to this Bylaw.
5. This Bylaw shall come into full force and take effect upon its adoption and shall be filed in the Prince George Land Title Office.
6. This Bylaw may be cited for all purposes as "Shaw Cable Lane Closure Bylaw No. 7367, 2002".


READ A FIRST TIME THIS THE 25<sup>th</sup> DAY OF March, 2002.

READ A THIRD TIME THIS THE 25<sup>th</sup> DAY OF March, 2002.

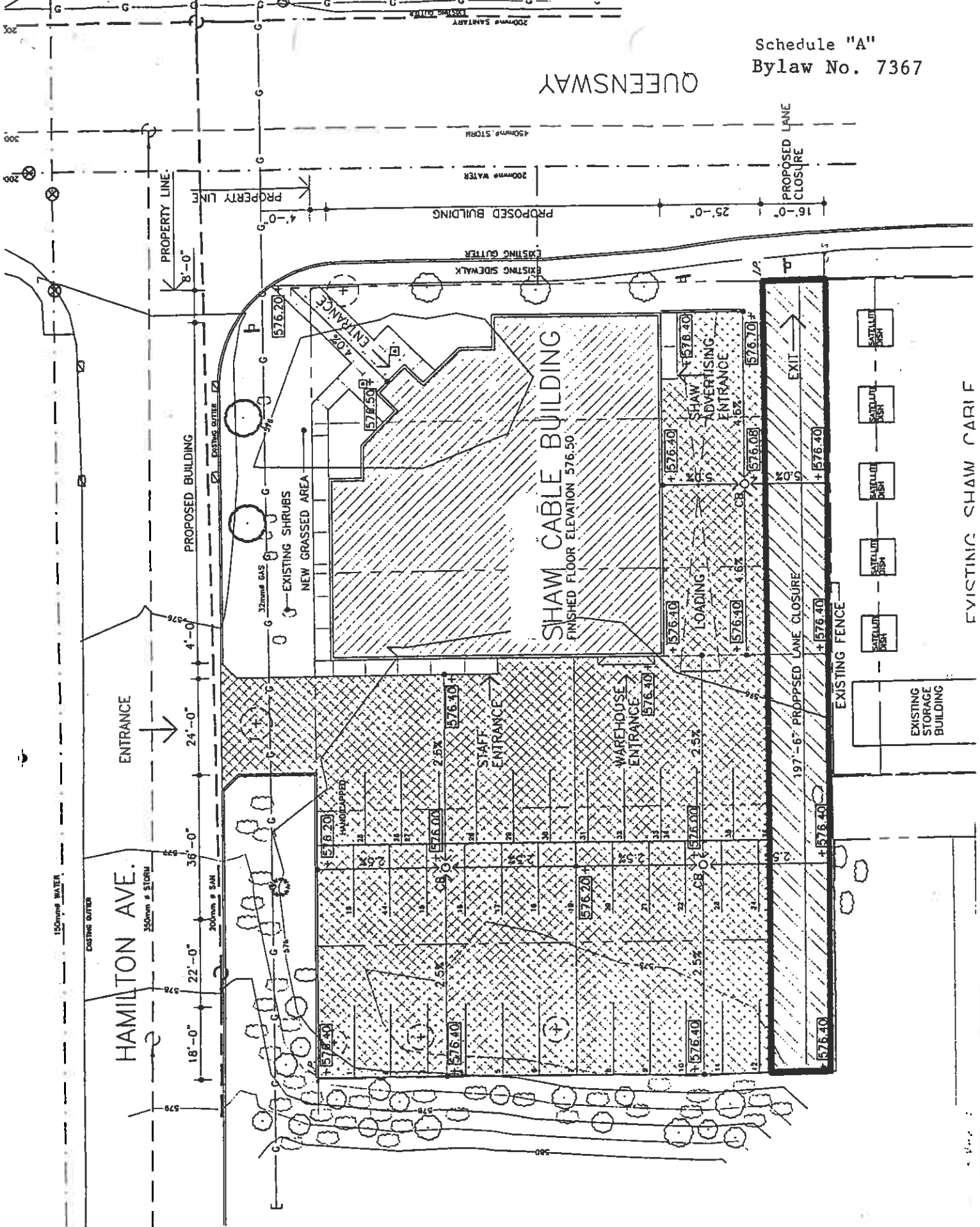
All three readings passed by a unanimous decision of Members of City Council present and eligible to vote.
