

CITY OF PRINCE GEORGE

BYLAW NO. 8008

A Bylaw of the City of Prince George authorizing the expenditure of monies from the Community Works Fund Reserve for capital projects as per the year 2007 capital budget.

WHEREAS there is an unappropriated balance in the Community Works Fund Reserve established by "Community Works Fund Reserve Bylaw No. 7937, 2006" of \$2 103 943, which is calculated as follows:

Balance in Reserve Fund at December 31, 2006	\$874 943
Add: Government of Canada – Community Works Fund Grant	1 229 000
Balance in Reserve Fund	<u>\$2 103 943</u>

AND WHEREAS it is deemed desirable to expend a portion of the monies set aside under said Bylaw No. 7937 for capital projects as per the year 2007 capital budget approved by Council;

NOW THEREFORE the Council of the City of Prince George in open meeting assembled, **ENACTS AS FOLLOWS:**

1. The sum of \$1 222 000 is hereby appropriated from the Community Works Fund Reserve to finance the following:

Leisure Services Department

-Coliseum – Radiant Spectator Heat	\$50 000
-CN Centre – Air Handling Diffusion	94 000
-Elksentre – Condenser Replacement	116 000
-Elksentre – Oil Separator Replacement	<u>22 000</u>

Subtotal \$282 000

Development Services Department

-Cycle Network Links Design	\$14 000
-Downtown Street Tree Planting	126 000
-Interface Fire Fuel Reduction	350 000
-River Road Storm Sewer Construction	300 000
-Storm System Rehabilitation Downtown	87 000
-Tennis Court/Ice Rink Lighting U/G	20 000
-Transit Infrastructure Improvements	<u>43 000</u>

Subtotal \$940 000

Total \$1 222 000

2. Should any of the above amount remain unexpended after the expenditures hereby authorized have been made, any unexpended balance shall be returned to the credit of the said Community Works Fund Reserve.
3. This Bylaw may be cited as "Community Works Fund Reserve Expenditure Bylaw No. 8008, 2007".


READ A THIRD TIME THIS THE **9th** DAY OF **JULY , 2007.**
