

CITY OF PRINCE GEORGE

BY-LAW NO. 3411

A By-Law of the City of Prince George to amend By-Law No. 2656 which By-Law regulated the extension of and connection to the storm sewer system of the City.

WHEREAS Council is desirous of amending Schedule "B" which provides for connection fees and winter surcharges;

NOW THEREFORE the Council of the City of Prince George in open meeting assembled, enacts as follows:

1. That Schedule "B" of By-Law 2656 is hereby repealed and a new Schedule "B", a copy of which is attached to this By-Law, adopted in its place.
2. This By-Law shall come into full force and effect upon its final passage and adoption.
3. This By-Law may be cited for all purposes as "Amendment to Storm Sewer By-Law No. 2656, By-Law No. 3411, 1979"

READ A FIRST TIME THIS THE *26th* DAY OF *March*, 1979.

READ A SECOND TIME THIS THE *26th* DAY OF *March*, 1979.

READ A THIRD TIME THIS THE *26th* DAY OF *March*, 1979.

ALL THREE READINGS PASSED BY A *unanimous* DECISION OF MEMBERS OF THE CITY COUNCIL.

RECONSIDERED, FINALLY PASSED AND ADOPTED THIS THE *9th* DAY OF *April* 1979, BY A *unanimous* DECISION OF MEMBERS OF CITY COUNCIL PRESENT AND ELIGIBLE TO VOTE.

SCHEDULE "B"

1. Pursuant to Section 4.1 the normal service connection fee from April 16th to October 31st shall be as follows:

<u>(a) CONNECTION SIZE</u>	<u>CONNECTION FEE</u>
4 inches	\$ 550.00
6 inches	700.00
* 8 inches	2,240.00
* 10 inches	2,360.00
* 12 inches	2,480.00
* includes manhole construction allowance	1,400.00

- (b) Where curb and gutter has been installed on the street prior to the sewer connection application being received, the extra cost of connection over and above the connection fee shall be:

1 service per trench	\$ 500.00
2 services per trench	590.00
3 services per trench	650.00

to cover repairs to the curb, gutter and pavement.

- (c) Where a concrete sidewalk exists prior to the sewer connection application being received, the extra cost of connection over and above the connection fee above shall be:

5 feet width	\$ 250.00
6 feet 6 inch width	300.00

to cover repairs to the sidewalk.

- (d) Where two or more utility service connections are installed in one trench with a distance of separation in either the vertical or horizontal directions not exceeding one foot, a reduction of twenty percent (20%) of the connection fees listed above shall apply.

2. WINTER SURCHARGE

All applications for service connections from November 1st to April 15th shall pay the actual cost of the connection. The Engineer shall estimate the cost of the connection, which fee must be paid to the Collector prior to the installation of the connection. Any adjustment if necessary, will be made after installation of the connection and any amount due shall be paid by the owner within 30 days of the date of the invoice.
