A Bylaw of the City of Prince George to designate certain lands and to amend the City of Prince George Soil Removal and Deposit Bylaw No. 7022, 1999.

WHEREAS pursuant to the provisions of Section 723 of the Local Government Act, Council is empowered to regulate or prohibit the removal or deposit of soil;

AND WHEREAS the Council of the City of Prince George has deemed it desirable that Schedule "A" of Soil Removal and Deposit Bylaw No. 7022, 1999, be amended by designating the N ½ of NW ¼ of District Lot 4053, as a Soil Removal or Deposit Area.

APPLICANT: PRM Contracting for Land and Water BC Inc.
LOCATION: N ½ of NW ¼ of District Lot 4053, Cariboo District

AND WHEREAS a Public Hearing was held in accordance with the Local Government Act and notice of such hearing was given as required by Bylaw;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That Schedule "A" of Soil Removal and Deposit Bylaw No. 7022, 1999, be amended by designating N ½ of NW ¼ of District Lot 4053, Cariboo District be a Soil Removal or Deposit Area, as shown outlined in a heavy black line on the map attached to, and forming part of, this Bylaw as Appendix "A".
2. That the Mayor and Clerk are hereby empowered to do all things necessary to give effect to this Bylaw.
3. That this Bylaw may be cited for all purposes as "Soil Removal and Deposit Bylaw No. 7022, 1999, Amendment Bylaw No. 7513, 2003."

READ A SECOND TIME THIS THE 26th DAY OF *May*, 2003.




