## BY-LAW NO. 3759

A By-Law of the City of Prince George to amend By-Law No. 2656 which By-Law regulated the extension of and connection to the storm sewer system of the City.

WHEREAS Council is desirous of amending Schedule "B" which provides for connection fees and winter surcharges;

NOW THEREFORE the Council of the City of Prince George in open meeting assembled, enacts as follows: 

- That Schedule "B" of By-Law 2656 as amended by By-Law No. 3584 is hereby repealed and a new Schedule "B", a copy of which is attached to this By-Law, adopted in its place.
- This By-Law shall come into full force and effect upon its final passage and adoption.
- This By-Law may be cited for all purposes as "Amendment to Storm Sewer By-Law No. 2656, By-Law No. 3759, 1981".

## SCHEDULE "B"

1. Pursuant to Section 4.1 the normal service connection fee from April 16th to October 31st shall be as follows:

(a)	CONNECTION SIZ	E CONNECTION FEE

(b) Where curb and gutter and asphaltic pavement have been installed on the street prior to the sewer connection application being received, the extra cost of connection over and above the connection fee shall be:

1	service per trench	\$	825.00
2	services per trench		975.00
3	services per trench	1	,080.00

to cover repairs to the curb, gutter and pavement.

(c) Where a concrete sidewalk exists prior to the sewer connection application being received, the extra cost of connection over and above the connection fee above shall be:

1.5	metre	width	\$308.00
2.0	metre	width	363.00

to cover repairs to the sidewalk.

FROST CHARGE (Winter Surcharge)

All applications for service connections from November 1st to April 15th shall pay the actual cost of the connection. The applicant will be required to authorize, by signature, a third party billing A/C notification agreeing to pay the additional cost over the scheduled fee incurred during installation of the connection. Any adjustment, if necessary, will be made after installation of the connection and any amount due shall be paid by the owner within thirty (30) days of the invoice.
