

CITY OF PRINCE GEORGE
BYLAW NO. 8538

A Bylaw of the City of Prince George to amend "City of Prince George Parking and Traffic Bylaw No. 6056, 1993".

WHEREAS Council of the City of Prince George enacted City of Prince George Parking and Traffic Bylaw No. 6056, 1993 to regulate parking and traffic on highways within the City of Prince George.

AND WHEREAS Council deems it desirable to amend City of Prince George Parking and Traffic Bylaw No. 6056, 1993 by deleting Section 58.1 and replacing certain wording in Section 71.

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That City of Prince George Parking and Traffic Bylaw No. 6056, 1993, is hereby amended by:

- a) deleting Section 58.1 "Eligibility" in its entirety; and
- b) deleting Section 71 "Vehicles Subject to Removal When Illegally Parked" in its entirety and replacing it with a new Section 71 "Vehicles Subject to Removal When Illegally Parked" as follows:

"In addition to any other penalties provided by this Bylaw, upon discovery of any vehicle parked, stopped or standing on any highway in contravention of the provisions of this Bylaw, a Police Officer, Parking Control Officer, Bylaw Enforcement Officer or person authorized by the Superintendent of Operations may cause such vehicle to be moved or taken to and placed or stored in a suitable place and all costs, including the Administrative Towing Costs provided in Schedule "C-2(d)" of the "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", and charges for the removing, care and storage thereof, if any, are a lien upon the vehicle being released."

- 2. The Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this bylaw.
- 3. This bylaw may be cited for all purposes as "City of Prince George Parking and Traffic Bylaw No. 6056, 1993, Amendment Bylaw No. 8538, 2013".

READ A SECOND TIME THIS THE **9th** DAY OF **SEPTEMBER** , 2013.
