A By-Law of the City of Prince George to amend Storm Sewer By-Law No. 2656, 1974 which regulates the extension of and connection to the storm sewer system of the City.

WHEREAS Council is desirous of amending Schedule "B" to Storm Sewer By-Law No. 2656 as amended, which provides for connection fees and additional surcharges;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembly enacts as follows:

1. That Storm Sewer By-Law No. 2656, 1974 as amended, be further amended by deleting Schedule "B" thereof in its entirety and substituting therefor, a revised Schedule "B" in the form attached hereto as Appendix "A".
2. That "Storm Sewer By-Law No. 2656, Amendment By-Law No. 4805, 1986" be and is hereby repealed.
3. This By-Law shall come into full force and effect upon its final passage and adoption.
4. This By-Law may be cited for all purposes as "Storm Sewer By-Law No. 2656, 1974, Amendment By-Law No. 4983, 1987".

READ A FIRST TIME THIS THE 15<sup>th</sup> DAY OF June, 1987.

READ A SECOND TIME THIS THE 15<sup>th</sup> DAY OF June, 1987.

READ A THIRD TIME THIS THE 15<sup>th</sup> DAY OF June, 1987.

All three readings passed by a unanimous decision of Members of City Council present and eligible to vote.

SCHEDULE B

to

City of Prince George Storm Sewer By-Law No. 2656

1. CONNECTION FEES

Pursuant to Section 4.1 the normal connection fees from April 16th to October 31st shall be as follows:

<u>(a)</u>	<u>CONNECTION SIZE</u>	<u>CONNECTION FEE</u>
	100 mm	\$1,100.00
	*150 mm	\$4,170.00
	*200 mm	\$4,480.00
	*250 mm	\$4,715.00
	*300 mm	\$4,955.00
	*375 mm	\$5,170.00
	*450 mm	\$5,420.00

\* Sanitary & storm sewer connections 150 mm. dia. and up, require a manhole connection to the sewer main. If no new manhole is required, a reimbursement of \$1,500 will be made.

(b) Where curb, gutter and asphaltic pavement have been installed on the street prior to the sewer connection application being received, the extra cost of connection to cover repairs, over and above the connection fee, shall be:

1 service per trench	\$1,535.00
2 services per trench	\$1,810.00
3 services per trench	\$2,010.00

(c) Where street paving has been installed and must be cut to effect the installation of the connection, the extra cost of connection to cover repairs, over and above the connection fee, shall be:

1 service per trench	\$ 877.00
2 or more services per trench	\$1,095.00

(d) Where concrete sidewalk exists prior to the sewer connection application being received, the extra cost of connection to cover repairs, over and above the connection fee in (a) above and the surcharge in (b) above, shall be:

1.5 metre width	\$405.00 (per trench)
2.0 metre width	\$475.00 (per trench)
2.5 metre width	\$565.00 (per trench)

2. INSTALLATION

Upon receipt of the connection fee, the Engineer will, within ninety days, weather permitting, provide and install a service connection to the applicant's property. If such connection is not practicable the Engineer will so notify the applicant within sixty days and the City shall refund charges or fees paid to the City by the applicant.

3. FROST CHARGE (WINTER SURCHARGE)

All applications for service connections received between November 1st and April 15th shall pay the actual cost of the connection. The applicant will be required to authorize, by signature, a third party billing A/C notification agreeing to pay additional costs over the scheduled fee, incurred during the installation of the connection. Any adjustment, if necessary, will be made after the installation of the connection and any due amount shall be paid by the applicant within (30) days of the date of the invoice.
