

**CITY OF PRINCE GEORGE**  
**BYLAW NO. 7971**

**A Bylaw of the City of Prince George to stop up and close to traffic a portion of unconstructed highway and remove its highway dedication in order to sell the closed portion of highway to the adjacent property owners.**

**WHEREAS**, pursuant to "City of Prince George Delegation of Authority - Real Estate Bylaw No. 7388, 2002", the City of Prince George has authorized the closure of a 130 square meter (1400 square feet) portion of unconstructed highway dedicated by Plan 22369, situated adjacent to Lots 93 and 94, District Lot 2433, Cariboo District, Plan 22369 as shown in heavy black outline on the attached Schedule "A", with the intention to sell the closed portion of highway to the adjacent property owners, Bryan Bernerd Wirgau (owner of Lot 93, District Lot 2433, Cariboo District, Plan 22369), for the sum of \$1,000.00, for consolidation with his property;

**AND WHEREAS** the Council of the City of Prince George has deemed it desirable that said road be stopped up and closed to traffic;

**AND WHEREAS** an opportunity has been provided for persons who consider they are affected by the Bylaw to make representation to Council;

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That the portion of unconstructed highway dedicated by Plan 22369 situated adjacent to Lots 93 and 94, District Lot 2433, Cariboo District, Plan 22369, as shown in heavy black outline on the attached Schedule "A", is hereby stopped up and closed to traffic.
2. That dedication of Highway dedicated by Plan 22369 situated adjacent to Lots 93 and 94, District Lot 2433, Cariboo District, Plan 22369, be removed.
3. Prior to adoption, this Bylaw shall be advertised once a week for two consecutive weeks in a newspaper circulating in the municipality.
4. The Mayor and Clerk are hereby empowered to do all things necessary to give effect to this bylaw.
5. This bylaw shall come into full force and take effect upon its adoption and shall be filed with the Registrar of the Land Title Office.
6. This Bylaw may be cited for all purposes as "4010 Diamond Drive Road Closure Bylaw No. 7971, 2007".


