

CITY OF PRINCE GEORGE
BYLAW NO.8631

A Bylaw to amend the “City of Prince George Comprehensive Fees and Charges Bylaw No.7557, 2004”.

WHEREAS Council enacted City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004, to establish fees and charges set out for the City;

AND WHEREAS Council deems it desirable to further amend the “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004”, by amending the fees and charges in Schedule “C”, Section “C-3 – Records and Administration”, and Section “C-5 – RCMP Support Services”, effective January 1, 2015;


NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. “City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004”, be amended as follows:
 - a) that Section C-3(a)(h)(viii) be repealed in its entirety;
 - b) that Section C-3(a)(h)(ix) be repealed in its entirety;
 - c) that Section “C-5 - RCMP Support Services” be repealed in its entirety and be replaced with a new Section “C-5 – RCMP Support Services”, as attached to and forming part of this bylaw as Appendix “A”.
2. The Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this bylaw.
3. This bylaw shall come into force on January 1, 2015.
4. This bylaw may be cited for all purposes as “City of prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004, Amendment Bylaw No. 8631, 2014”.
