

**CITY OF PRINCE GEORGE**  
**BYLAW NO. 8899**

**A Bylaw to amend the "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004".**

**WHEREAS** Council enacted "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", to establish the fees and charges set out for the City;

**AND WHEREAS** Council deems it desirable to amend the "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", by amending fees and charges in Section "C-1" that establishes the fees and charges for Responsible Animal Ownership;

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", be amended as follows:
  - a. That Schedule "C", Section "C-1", Fees and Charges for Animal Control be removed in its entirety and replaced with a new Schedule "C", Section "C-1" Fees and Charges for Responsible Animal Ownership, as attached to and forming part of this bylaw as Schedule "A".
2. The Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this bylaw.
3. This Bylaw may be cited for all purposes as "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004, Amendment Bylaw No. 8899, 2017".
4. This Bylaw shall come into force and take effect on the 1<sup>st</sup> day of January 2018.

READ A FIRST TIME THIS 6<sup>th</sup> DAY OF NOVEMBER , 2017.

READ A SECOND TIME THIS 6<sup>th</sup> DAY OF NOVEMBER , 2017.

READ A THIRD TIME THIS 6<sup>th</sup> DAY OF NOVEMBER , 2017.

All three readings passed by a **UNANIMOUS** decision of Members of City Council present and eligible to vote.
