

CITY OF PRINCE GEORGE
BYLAW NO. 7859

A Bylaw to amend the "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004".

WHEREAS Council enacted "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", to establish the fees and charges set out for the City;

AND WHEREAS Council deems it desirable to amend the "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", by adding the fees and charges in Schedule "A", Section "A-17", to establish the fees and charges for the Commercial Vehicle Licencing;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That "City of Prince George Comprehensive Fees and Charges Bylaw No. 7557, 2004", be amended by adding a new Schedule "A-17", attached to and forming part of this bylaw as Appendix "A".
2. The Mayor and City Clerk are hereby empowered to do all things necessary to give effect to this bylaw.
3. This bylaw may be cited for all purposes as "City of Prince George Fees and Charges Bylaw No. 7557, 2004, Amendment Bylaw No. 7859, 2007".

The fees due under the Commercial Vehicle Licensing Bylaw No. 7852 and section 669 (1), (2) and (3) and 671 (1) of the Local Government Act are as follows:
