

CITY OF PRINCE GEORGE

Bylaw No. 8187, 2008

A Bylaw to amend the "City of Prince George Parking and Traffic Bylaw No. 6056, 1993".

WHEREAS Council of the City of Prince George enacted "City of Prince George Parking and Traffic Bylaw No. 6056, 1993" to regulate parking and traffic on highways within the City of Prince George;

AND WHEREAS it is deemed desirable to amend said Bylaw No. 6056 to reflect changes to parking strategies.

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, enacts as follows:

1. That Section 67 of the "City of Prince George Parking and Traffic Bylaw No. 6056, 1993" is amended by removing the words "as detailed in Schedule "E".
2. That Section 67.1 of the "City of Prince George Parking and Traffic Bylaw No. 6056, 1993" is repealed.
3. That Schedule "A" is repealed in its entirety and replaced with the attached from of Schedule "A" and forming part of this bylaw.
4. That Schedule "B" is repealed.
5. That Schedule "C" is repealed.
6. That Schedule "E" is repealed.
7. That Schedule "F" is repealed.
8. That this bylaw comes into force on January 1, 2009.
9. This bylaw may be cited for all purposes as "City of Prince George Parking and Traffic Bylaw No. 6056, 1993, Amendment Bylaw No. 8187, 2008".

READ A SECOND TIME THIS THE **3rd** DAY OF **NOVEMBER** , 2008.


READ A THIRD TIME THIS THE **3rd** DAY OF **NOVEMBER** , 2008.

The penalty to be levied in respect of these offences shall be \$25.00 if such penalty is paid prior to the swearing of an Information. Thereafter the penalty shall be \$50.00.
