

CITY OF PRINCE GEORGE

BYLAW NO. 7467

A Bylaw to amend "City of Prince George Business License Bylaw No. 6279, 1994".

WHEREAS pursuant to the Local Government Act, Council of the City of Prince George is authorized to issue Business Licenses and to regulate businesses within the boundaries of the City of Prince George;

AND WHEREAS the City of Prince George, by Bylaw No. 6279 and amendments thereto, regulates businesses within the boundaries of the municipality;

AND WHEREAS it is deemed desirable that "City of Prince George Business License Bylaw No. 6279, 1994" be further amended;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, enacts as follows:

1. "City of Prince George Business License Bylaw No. 6279, 1994" is hereby amended as follows:
  - a) Deleting in its entirety Schedule "A" of Bylaw No. 6279 and substituting therefore a new Schedule "A", attached to and forming part of this Bylaw as Schedule "A".
  - b) Deleting in its entirety Schedule "B" of Bylaw No. 6279 and substituting therefore a new Schedule "B", attached to and forming part of this Bylaw as Schedule "B".
2. The Mayor and Clerk are hereby empowered to all things necessary to give effect to this bylaw.
3. This bylaw may be cited for all purposes as "City of Prince George Business Licence Bylaw No. 6279, 1994, Amendment Bylaw No 7467, 2003".

READ A FIRST TIME THIS THE 3<sup>rd</sup> DAY OF November 2003.

READ A SECOND TIME THIS THE 3<sup>rd</sup> DAY OF November 2003.

READ A THIRD TIME THIS THE 3<sup>rd</sup> DAY OF November 2003.

All three readings passed by a unanimous decision of Members of City Council present and eligible to vote.

ADOPTED THIS THE 17<sup>th</sup> DAY OF November 2003, BY A unanimous DECISION OF ALL MEMBERS OF CITY COUNCIL PRESENT AND ELIGIBLE TO VOTE.
