

**CITY OF PRINCE GEORGE**

**BYLAW NO. 8217**

**A Bylaw of the City of Prince George to rezone certain lands and to amend the City of Prince George Zoning Bylaw No. 7850, 2007.**

**WHEREAS** pursuant to the provisions of Section 903 of the Local Government Act, in relation to zoning, the Council of the City of Prince George is empowered to make regulations thereto;

**AND WHEREAS** "City of Prince George Zoning Bylaw No. 7850, 2007" has been adopted to make regulations thereto;

**AND WHEREAS** the Council of the City of Prince George has deemed it desirable that certain lands be rezoned from P1: Parks and Recreation to P3: Major Institutional to allow a Cancer Patient Lodge, or other uses, pursuant to the P3: Major Institutional zoning designation;

**APPLICANT:** City of Prince George  
**LOCATION:** 1100 Alward Street

**AND WHEREAS** a Public Hearing was held in accordance with the Local Government Act and notice of such hearing was given as required by Bylaw;

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That the "City of Prince George Zoning Bylaw No. 7850, 2007", be, and is, hereby amended as follows: Lot 1, District Lot 343, Cariboo District, Plan 18364, is hereby rezoned from P1: Parks and Recreation to P3: Major Institutional, as shown outlined in heavy black line on the map attached to, and forming part of, this bylaw as Appendix "A".
2. That the Zoning Map referred to as Schedule "A" of the "City of Prince George Zoning Bylaw No. 7850, 2007", shall be amended accordingly.
3. That the Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.
4. That this Bylaw may be cited for all purposes as the "City of Prince George Zoning Bylaw No. 7850, 2007, Amendment Bylaw No. 8217, 2009".

First Two readings passed by a unanimous decision of Members of City Council present and eligible to vote.


READ A THIRD TIME THIS THE 13th DAY OF JULY , 2009.

Third Reading passed by a unanimous decision of Members of City Council present and eligible to vote.


