

CITY OF PRINCE GEORGE
BYLAW NO. 9006, 2019

A Bylaw of the City of Prince George to amend the City of Prince George Zoning Bylaw No. 7850, 2007.

WHEREAS pursuant to the provisions of Section 479 of *the Local Government Act*, in relation to zoning, the Council of the City of Prince George is empowered to make regulations thereto;

AND WHEREAS "City of Prince George Zoning Bylaw No. 7850, 2007" has been adopted to make regulations thereto;

AND WHEREAS the Council of the City of Prince George has deemed it desirable that certain text and definitions be amended, added, removed, and replaced to clarify regulations in regard to cannabis production facilities;

AND WHEREAS a Public Hearing was held in accordance with the *Local Government Act* and notice of such hearing was given as required by Bylaw.

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. THAT "City of Prince George Zoning Bylaw No. 7850, 2007", be amended as follows:
 - a. That Section 5.17.2 be amended by deleting the words "Medical Marihuana Production Facilities (MMPF)" and replacing them with the words "Cannabis Production Facilities";
 - b. that Section 5.17.2 ii) be deleted in its entirety and replaced with the following:

"ii) The areas identified on Schedule "H" as "Boundary Industrial Park", "BCR Industrial Park", and "Danson Industrial Park", in accordance with the regulations identified in Section 12.1, 12.2, 12.3 and 12.5 of this Bylaw.";
 - c. that Section 12.5 be amended by inserting ", M5n" immediately after "M5"; and
 - d. that Section 12.5.2 be amended by inserting "• cannabis production facility, only in M5n".
2. THAT the Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.
3. THAT this Bylaw may be cited for all purposes as the "City of Prince George Zoning Bylaw 7850, 2007, Amendment Bylaw No. 9006, 2019".

READ A FIRST TIME THIS 4TH DAY OF FEBRUARY 2019.

READ A SECOND TIME THIS 4TH DAY OF FEBRUARY 2019.
