CITY OF PRINCE GEORGE BYLAW NO. 7837

A Bylaw of the City of Prince George to stop up and close to traffic a portion of unconstructed highway and remove its highway dedication with the intent to sell it to Belco Developments Ltd..

WHEREAS, pursuant to "City of Prince George Delegation of Authority - Real Estate Bylaw No. 7388, 2002", the City of Prince George has authorized the closure of a .327 ha (.81 acre) portion of unconstructed highway dedicated by Plan 1065, situated adjacent to Parcel A (J7598), Block 1, District Lot 1605, Cariboo District, Plan 1065, Except Plans PGP26549, PGP39134, PGP 41801 and PGP41802, as shown in heavy black outline on the attached Schedule "A", with the intention to sell it to Belco Development Ltd. for the sum of \$70,000;

AND WHEREAS the Council of the City of Prince George has deemed it desirable that said road be stopped up and closed to traffic;

AND WHEREAS an opportunity has been provided for persons who consider they are affected by the Bylaw to make representation to Council;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, ENACTS AS FOLLOWS:

- 1. That the portion of unconstructed highway situated adjacent to Parcel A (J7598), Block 1, District Lot 1605, Cariboo District, Plan 1065, Except Plans PGP36549, PGP39134, PGP41801, and PGP41802, as shown in heavy black outline on the attached Schedule "A", is hereby stopped up and closed to traffic.
- 2. That dedication of Highway dedicated by Plan 1065, adjacent to Parcel A (J7598), Block 1, District Lot 1605, Cariboo District, Plan 1065, Except Plans PGP36549, PGP39134, PGP41801, and PGP41802, be removed.
- 3. Prior to adoption, this Bylaw shall be advertised once a week for two consecutive weeks in a newspaper circulating in the municipality.
- 4. The Mayor and Clerk are hereby empowered to do all things necessary to give effect to this bylaw.
- 5. This bylaw shall come into full force and take effect upon its adoption and shall be filed with the Registrar of the Land Title Office.
- 6. This Bylaw may be cited for all purposes as "Westgate Phase IV-B Road Closure Bylaw No. 7837, 2006".




