

**CITY OF PRINCE GEORGE**

**BYLAW NO. 8127**

**A Bylaw of the City of Prince George to rezone certain lands and to amend the Prince George Zoning Bylaw No. 7850, 2007.**

**WHEREAS** pursuant to the provisions of Section 903 of the Local Government Act, in relation to zoning, the Council of the City of Prince George is empowered to make regulations thereto;

**AND WHEREAS** Bylaw No. 7850 has been passed to make regulations thereto;

**AND WHEREAS** the Council of the City of Prince George has deemed it desirable that the zoning map be altered to correctly reflect the change in zoning mandated by "City of Prince George Zoning Bylaw 7850, Amendment Bylaw No. 7978";

**APPLICANT:** City of Prince George  
**LOCATION:** 4300 Sturgeon Road

**AND WHEREAS** a Public Hearing was waived in accordance with the Local Government Act and notice of the waiving for such hearing was given as required by Bylaw;

**NOW THEREFORE** the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That Appendix "A" attached to "City of Prince George Zoning Bylaw 7850, Amendment Bylaw No. 7978" be replaced by Appendix "A" to this Bylaw, as shown outlined in heavy black line on the map attached to, and forming part of, this bylaw as Appendix "A".
2. That the Zoning Map referred to as Schedule "A" of the "City of Prince George Zoning Bylaw No. 7850, 2007", shall be amended accordingly.
3. That the Mayor and Clerk are hereby empowered to do all things necessary to give effect to this Bylaw.
4. That this Bylaw may be cited for all purposes as the "City Prince George Zoning Bylaw No. 7850, 2007, Amendment Bylaw No. 8127, 2008".

First Two readings passed by a **unanimous** decision of Members of City Council present and eligible to vote.

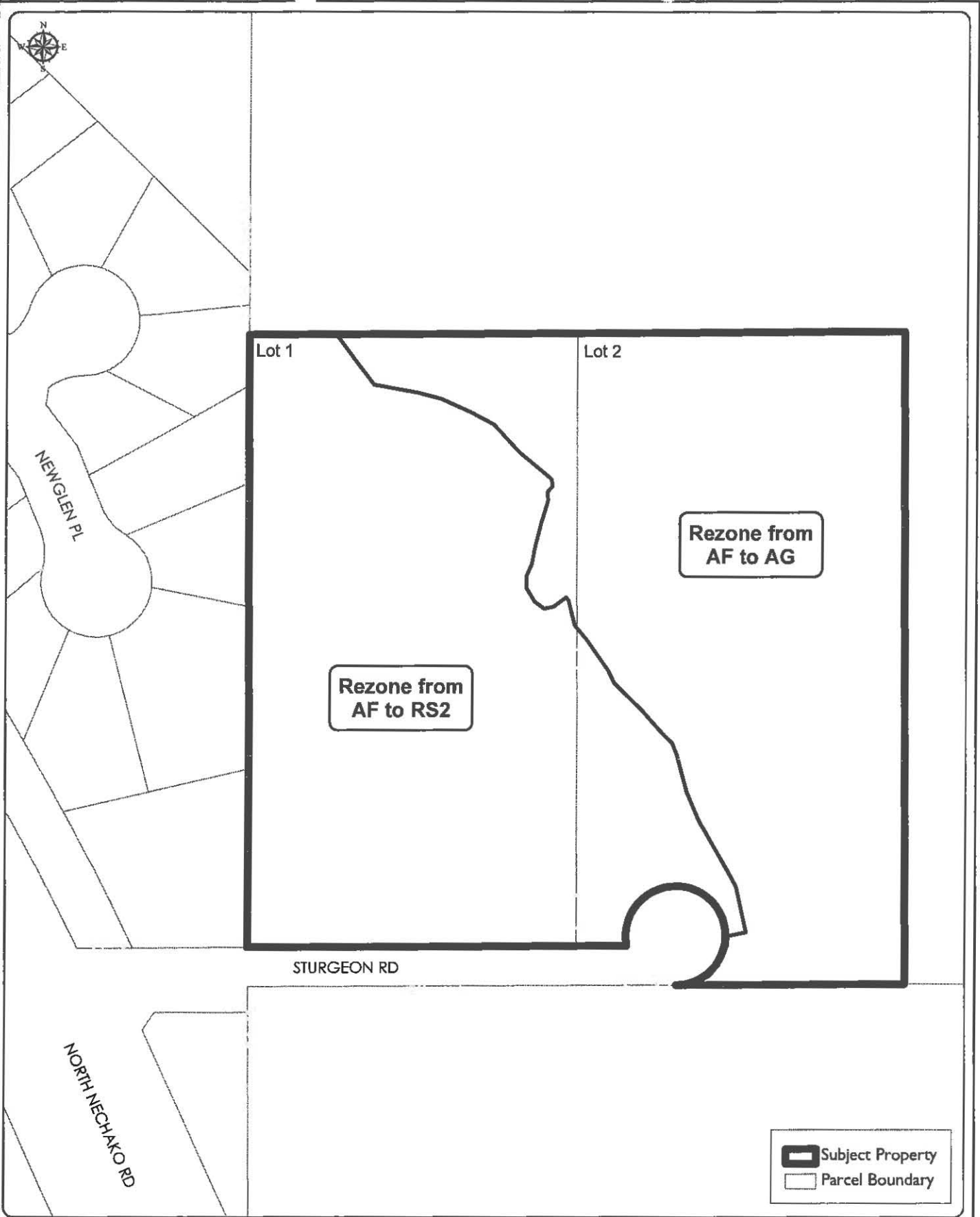
READ A THIRD TIME THIS THE **26th** DAY OF **MAY**, **2008**.
