

CITY OF PRINCE GEORGE
BYLAW NO. 8441

A Bylaw of the City of Prince George to amend the “City of Prince George Council Procedures Bylaw No. 8388, 2011”.

WHEREAS “City of Prince George Council Procedures Bylaw No. 8388, 2011” has been adopted to establish the general procedures to be followed by Council and Council committees in conducting their business;

AND WHEREAS Council deems it desirable to amend “City of Prince George Council Procedures Bylaw No. 8388, 2011”;

AND WHEREAS pursuant to Section 124 and Section 94 of the *Community Charter*, notice of intention to adopt this bylaw has been published once a week for two consecutive weeks in a newspaper circulating in the municipality.

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That “City of Prince George Council Procedures Bylaw No. 8388, 2011” be and is hereby amended by:
 - a) deleting the word “Tuesday” in section 21. (4) and substituting it with “Monday”.
 - b) deleting the word “Thursday” in section 21. (5) and substituting it with “Wednesday”.
 - c) deleting the word “Tuesday” in section 22. (1) and substituting it with “Monday”.
 - d) deleting section 23. (4) (a) in its entirety and substituting it with a new section 23. (4) (a) as follows:

“23.(4) (a) shall be emailed to each Council member at the email address designated by each respective Council member from time to time, and”
 - e) deleting the word “Tuesday” in section 26. (1) (a) and substituting it with “Monday”.
 - f) deleting the word “Tuesday” in section 30. (1) (a) and substituting it with “Monday”.
 - g) deleting the word “Tuesday” section 30. (1) (b) and substituting it with “Monday”.

2. That the Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this bylaw.
3. That this bylaw may be cited for all purposes as "City of Prince George Council Procedures Bylaw No. 8388, 2011, Amendment Bylaw No. 8441, 2012".
