

CITY OF PRINCE GEORGE

BY-LAW NO. 3948

A By-Law of the City of Prince George to amend By-Law No. 2656 which regulates the extension of and connection to the storm sewer system of the City.

WHEREAS Council is desirous of amending Schedule "B" which provides for connection fees and winter surcharges;

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, enacts as follows:

1. That Schedule "B" of By-Law No. 2656 as amended by By-Law No. 3759 is hereby repealed and a new Schedule "B", a copy of which is attached to and forms part of this By-Law, be substituted therefor.
2. This By-Law shall come into full force and effect upon its final passage and adoption.
3. This By-Law may be cited for all purposes as "Storm Sewer By-Law No. 2656, Amendment By-Law No. 3948, 1982".

READ A SECOND TIME THIS THE 29TH DAY OF MARCH, 1982.

READ A THIRD TIME THIS THE 29TH DAY OF MARCH, 1982.

STORM SEWER

SCHEDULE "B"

1. Pursuant to Section 4.1 the normal service connection fee from April 16th to October 31st shall be as follows:

<u>(a) CONNECTION SIZE</u>	<u>CONNECTION FEE</u>
100 mm	\$1,070.00
*150 mm	4,050.00
*200 mm	4,350.00
*250 mm	4,580.00
*300 mm	4,810.00
*375 mm	5,020.00
*450 mm	5,265.00

*includes manhole construction allowance \$2,700.00.

- (b) Where curb and gutter and asphaltic pavement have been installed on the street prior to the sewer connection application being received, the extra cost over and above the connection fee shall be:

1 service per trench	\$ 965.00
2 services per trench	1,140.00
3 services per trench	1,265.00

to cover repairs to the curb, gutter and pavement.

- (c) Where a concrete sidewalk exists prior to the sewer connection application being received, the extra cost of connection over and above the connection fee above shall be:

1.5 metre width	\$360.00
2.0 metre width	425.00

to cover repairs to the sidewalk.

2. FROST CHARGE (Winter Surcharge)

All applications for service connections from November 1st to April 15th shall pay the actual cost of the connection. The applicant will be required to authorize, by signature, a third party billing A/C notification agreeing to pay the additional cost over the scheduled fee incurred during installation of the connection. Any adjustment, if necessary, will be made after installation of the connection and any amount due shall be paid by the owner within thirty (30) days of the invoice.
