

CITY OF PRINCE GEORGE
BYLAW NO. 8615

A Bylaw of the City of Prince to amend the City of Prince George Second-Hand Dealers and Pawnbrokers Bylaw No. 8098, 2008.

WHEREAS, Council may, pursuant to s. 8(6) of the *Community Charter*, regulate in relation to business;

AND WHEREAS, Council considers it necessary to regulate the businesses of second-hand dealers within the City of Prince George;

AND WHEREAS, Council may, pursuant to s. 59 of the *Community Charter*, require and prohibit in relation to persons engaged in the business activity of purchasing, taking in barter or receiving used or second hand goods;

AND WHEREAS, Council may, pursuant to s. 154 of the *Community Charter*, delegate its powers, duties and functions to an officer or employee of the City;

AND WHEREAS, "City of Prince George Second-Hand Dealers and Pawnbrokers Bylaw No. 8098, 2008" has been adopted to make regulations thereto;

AND WHEREAS, the Council of the City of Prince George has deemed it desirable that the City of Prince George Second-Hand Dealers and Pawnbrokers Bylaw No. 8098, 2008 be amended by revising a definition.

NOW THEREFORE the Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That the City of Prince George Second-Hand Dealers and Pawnbrokers Bylaw No. 8098, 2008, be amended as follows:
 - a) that video game discs/cartridges be excluded from the definition of "second-hand property" in Section 1.2 by inserting a new paragraph j) after the phrase "but does not include", as follows :

" j) video game disks/cartridges"
2. The Mayor and Corporate Officer are hereby empowered to do all things necessary to give effect to this Bylaw.
3. That this Bylaw may be cited for all purposes as the "City of Prince George Second-Hand Dealers and Pawnbrokers Bylaw No. 8098, 2008, Amendment Bylaw No. 8615, 2014".
