

CITY OF PRINCE GEORGE

BYLAW NO. 7574

A Bylaw to amend Water Regulation and Rates Bylaw No. 7479, 2003, by removing the fees and charges therein and placing them in the Consolidated Fees and Charges Bylaw.

WHEREAS Council enacted the Water Regulation and Rates Bylaw No. 7479, 2003, to operate and regulate the waterworks service and the provision of water in the Municipality, and to impose connection fees, water rates and charges for use of said waterworks, and to encourage the conservation of water;

AND WHEREAS Council wishes to amend Bylaw 7479 by removing the fees and charges levied therein and placing those fees and charges in "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004";

NOW THEREFORE, Council of the City of Prince George, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. That Schedules "A" and "D" are hereby removed in their entirety and placed in the "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004" as Schedules "A-16(a)" and "A-16(b)", respectively;
2. That Section 5.1 is hereby amended by removing the words "Schedule "A" of this Bylaw" and replacing them with the words "Schedule "A-16(a)" of the "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004"."
3. That Section 5.7 is hereby amended by removing the words "as provided in Schedule "A" and replacing them with the words "as provided in Schedule "A-16(a)" of the "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004"."
4. That Section 6.3 is hereby amended by removing the words "as provided in Schedule "D" of this Bylaw" and replacing them with the words "as provided in Schedule "A-16(b)" of the "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004"."
5. That Section 6.4.1 is hereby amended by removing the words "in Schedule "D" of this Bylaw" and replacing them with the words "in Schedule "A-16(b)" of the "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004"."
6. That Section 7.1 is hereby amended by removing the words "in Schedule "D"." and replacing them with the words "in Schedule "A-16(b)" of the "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004"."
7. That Section 7.1.3 is hereby amended by removing the words "in Schedule "D"." and replacing them with the words "in Schedule "A-16(b)" of the "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004"."
8. That Section 8.3.1 is hereby amended by removing the words "in Schedule "D"." and replacing them with the words "in Schedule "A-16(b)" of the "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004"."

9. That Section 9.4.1 is hereby amended by removing the words "in Schedule "D"." and replacing them with the words "in Schedule "A-16(b)" of the "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004"," where applicable.
10. That Section 9.4.3 is hereby amended by removing the words "in Schedule "D" of this Bylaw." and replacing them with the words "in Schedule "A-16(b)" of the "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004"."
11. That Section 9.4.4 is hereby amended by removing the words "in Schedule "D" of this Bylaw." and replacing them with the words "in Schedule "A-16(b)" of the "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004"."
12. That Section 9.4.5 is hereby amended by removing the words " in Schedule "D" of this Bylaw" and replacing them with the words "in Schedule "A-16(b)" of the "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004"."
13. That Section 9.5 is hereby amended by removing the words "in Schedule "D" of this Bylaw." and replacing them with the words "in Schedule "A-16(b)" of the "City of Prince George Consolidated Fees and Charges Bylaw No. 7557, 2004"."
14. That "Water Regulation and Rates Bylaw No. 7604, 2003, Amendment Bylaw No. 7604, 2004" is hereby repealed in its entirety.
15. That Mayor and Clerk are hereby empowered to do all things necessary to give effect to this Bylaw.
16. This Bylaw may be cited for all purposes as "Water Regulation and Rates Bylaw No. 7479, 2003, Amendment Bylaw No. 7574, 2004".


READ A FIRST TIME THIS THE 4th DAY OF October , 2004.

READ A SECOND TIME THIS THE 4th DAY OF October , 2004.


READ A THIRD TIME THIS THE 4th DAY OF October , 2004.
