2. That Authorization Issuance Land Use Contract No. LU 38-75, By-law No. 2769, 1975, is hereby repealed.
3. That the Mayor and Corporate Officer are hereby authorized to sign and seal any documents necessary to effect the discharge of the Land Use Contract and give this Bylaw effect, and to deliver the same as acts and deeds of the City of Prince George.

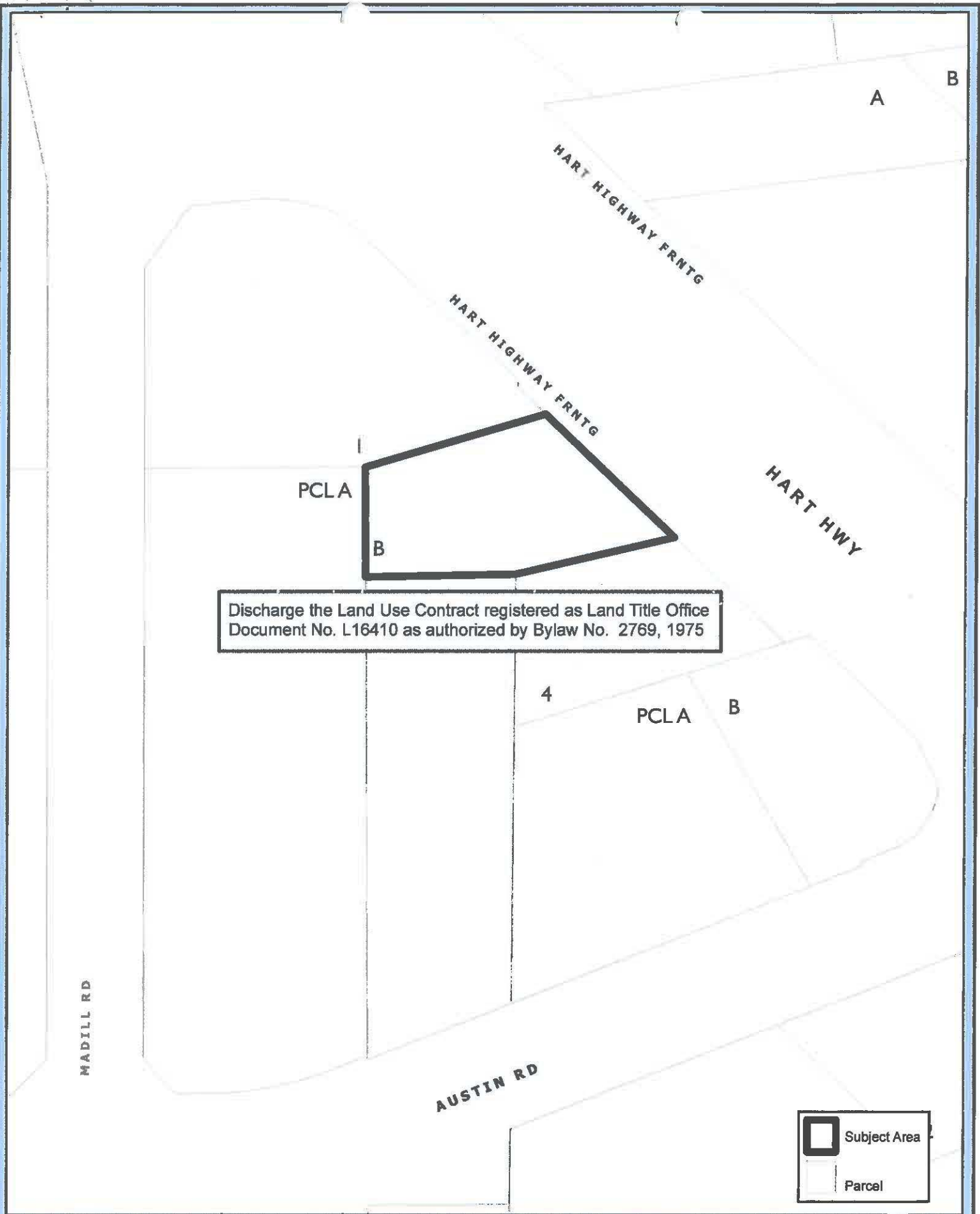
