BYLAW NO. 7986

A Bylaw to amend Bylaw No. 7465, 2003, to allow for the removal of the road dedication authorized by Munro Street Closure Bylaw No. 7465, 2003.

WHEREAS Council of the City of Prince George adopted “Munro Street Road Closure Bylaw No. 7465, 2003”, that authorized the closure of part of the road adjacent to the West of the property legally described as Parcel 1, District Lot 2508, Cariboo District, Plan PGP43052 and establishes as road parts of Lot 2, District Lot 2508, Cariboo District, Plan 9467 and Lot 1, District Lots 2508 and 2611, Cariboo District, Plan 9467, Except Plan 21294, as an intent of an exchange to facilitate for the creation of a walkway and road dedication;

AND WHEREAS the City petitioned the Ministry of Community, Aboriginal and Women’s Services to vest title of the aforementioned closed road in the name of the City for subsequent exchange of the road for other lands;

AND WHEREAS the City is required in its road closure bylaws to indicate that the road dedication is to be removed and that the removal is to be submitted to the Land Title Office for registration;

NOW THEREFORE, in open meeting assembled, Council of the City of Prince George hereby **ENACTS AS FOLLOWS:**

1. That Paragraph 1. of Bylaw No. 7465, 2003 be, and is, hereby removed in its entirety and replaced by the following:
 1. That Bylaw No. 7465, 2003, authorizes the closure of part of the road adjacent to Parcel 1, District Lot 2508, Cariboo District, Plan PGP43052 and establishes as road parts of Lot 2, District Lot 2508, Cariboo District, Plan 9467 and Lot 1, District Lots 2508 and 2611, Cariboo District, Plan 9467, Except Plan 21294 (Munro Street) is hereby stopped and closed to traffic, and that the dedication of highway on the noted portion of unconstructed highway is hereby removed as shown in heavy black outline on the attached Schedule “A” attached to, and forming part of, this bylaw.
2. The Mayor and Clerk are hereby empowered to do all things necessary to give effect to this Bylaw.
3. This Bylaw may be cited for all purposes as “Munro Street Road Closure Bylaw No. 7465, 2003, Amendment Bylaw No. 7986, 2007”.

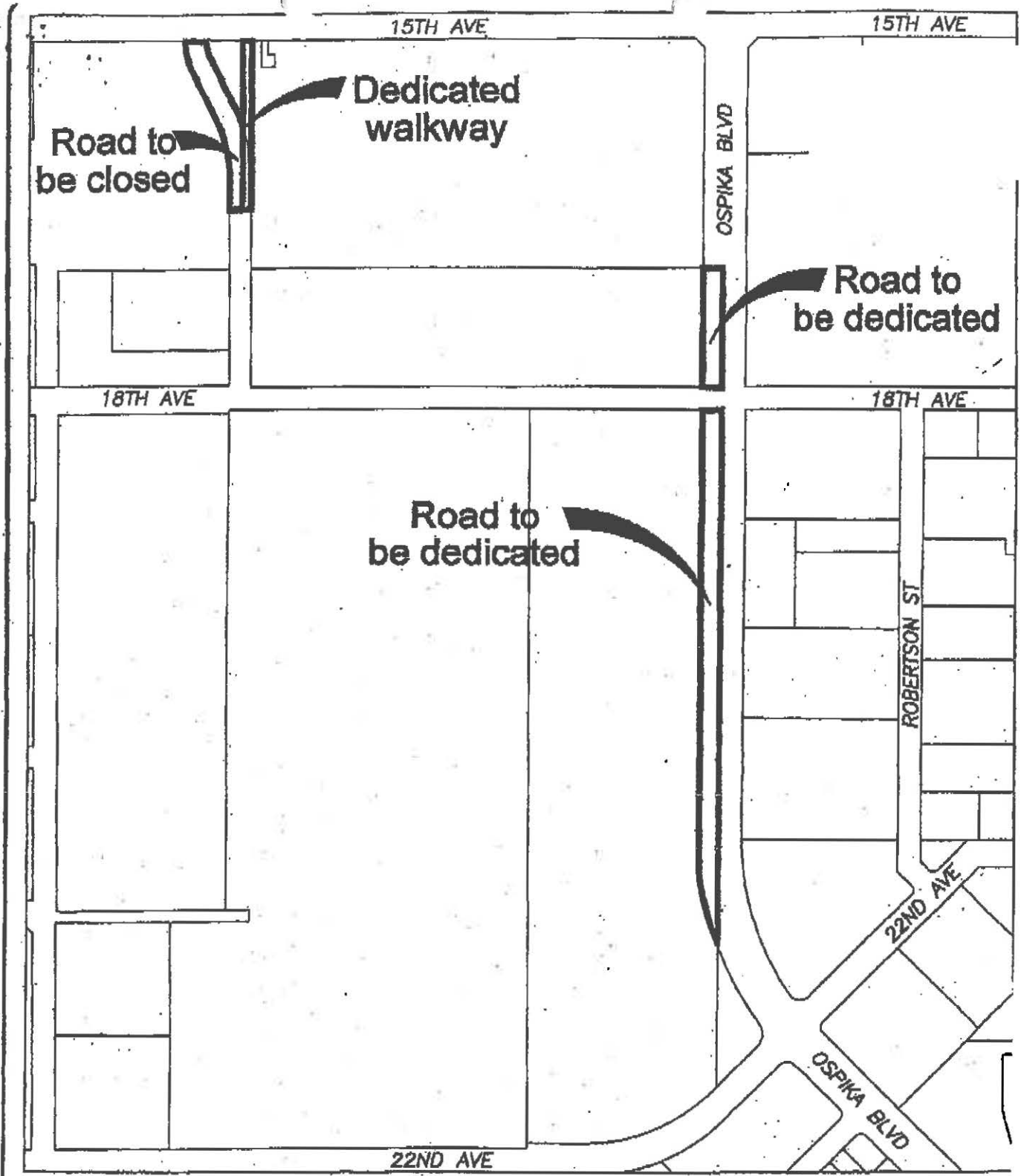
READ A THIRD TIME THIS THE **25th** DAY OF **JUNE** , **2007**.
